



## **Public Meeting** **Site Selection for the** **Sedona Maintenance & Operations facility**

**Thursday October 20, 2022**  
**Time: 4:00 p.m. to 6:00 p.m. (MST)**

*A Site Selection Study has been completed for the Maintenance and Operations (M&O) Facility necessary to provide Transit throughout the City. A M&O Facility's primary function is to store and maintain the transit fleet. The Consultant Team evaluated seven (7) potential sites for the M&O facility and has ultimately recommended **Site 1 which is located at 7420 W. SR-89A** (north of the City Wastewater Treatment Plant approximately five miles out of city limits). According to the study, Site 1 is recommended due to having minimal earthwork, large lot size, a compatible land use with adjacent parcels, and ease of access. It is a City-owned parcel and would not have a disproportionately high and adverse impact on environmental justice communities. To complete the Site Selection process and make this project eligible for Federal Funding, a Public Meeting will be held to discuss the Site Selection Process, take any comments, and answer any questions. We encourage all planning to attend to read the enclosed Site Selection Study and associated maps of the sites evaluated.*

This meeting is open the general public and will be held remotely via ZOOM™. There will be NO physical location for this meeting.
